ON THE INTERSECTIONS OF ARCHIVISTS, ARCHAEOLOGISTS, AND HISTORIANS IN LIBRARY PRACTICE: AN EXPLORATORY APPROACH

Abstract

Many advances and developments in Library and Information Science are attributable to the influence of other fields or sub-fields whose works have aided library theory and practice. However, some of the contributions made by these fields or disciplines to library practice need to be studied or investigated in more detail. It is in light that this paper seeks to examine the role of archivists, archaeologists, and historians in library practice. Using an exploratory approach, this work identified vital areas where archivists, archaeologists, and historians have enhanced library practice. The paper shows, among other things, that archaeological discoveries, archival preservations, and historical records and documents enrich repositories of libraries. The paper concludes that library practitioners will continue to rely on the useful contributions of archaeologists, archivists, and historians to strengthen their professional practice. The paper recommends areas of collaboration among the fields to strengthen library practice.

Introduction

The field of Library and Information Science has evolved over the centuries. Yan (2011) notes that the evolution within information science has brought about interdisciplinary connections among emerging disciplines. These inter-disciplinary connections play a significant role in not just the evolution of the affiliate disciplines, but also in their organisation and operations. It has been demonstrated that technological disruptions and market needs have influenced educational institutions to mount pedagogical changes worldwide from time to time (Safir, n.d.). Accordingly, sub-fields, such as archiving, information science, and librarianship, have emerged as distinct disciplines with their own identities to meet market and academic needs. Such needs enrich the experience, work and collaboration between the disciplines.

The inter-connectedness of disciplines means therefore that no single discipline is independent. The interdependence of knowledge makes it almost difficult to find any discipline which relies exclusively on its disciplinary progress. Among other things, such inter-connectedness fosters collaboration, stimulates the exchange of information, creates partnerships, and promotes diversity. Chen (2024) observes that intersection and collaboration between disciplines broaden the scope and frontiers of a discipline and research. It shapes the related discipline and gives it a better focus. It charts new directions of the discipline and resolves emerging challenges. This is true of many fields, such as Library and Information Science and its related or affiliate disciplines, namely, archaeology, history, and archival management. It is because of this that this work examines the intersection between and among them.

Conceptual Review

Many concepts and terms are repeatedly used in this paper, namely, archiving, archaeology, history and library practice. Though different, they share some fundamental relationship with library and information science practice. Archaeology is defined as the gathering of artefacts. However, archaeology is much more than gathering artefacts (Nicholson, 2005) because archaeology interprets the meaning behind those artefacts in time and history. Archaeological findings help to interpret artefacts to provide humanity with a logical understanding of events, people, and time. Mekonnen, et al. (2022) note that archaeologists help preserve artefacts, which builds their credibility and validity—a goal librarians also try to uphold.

Archiving and documentation are significant to the work of library practitioners. Archiving is the practice of storing historical records or documents in a depository. The use of artefacts, such as wax, papyrus, leather, clay, parchment, paper and wood to keep records (Kargbo, 2016), though archival practice, enhances library practitioners' preservation and distribution of information. Archive is considered distinct from the library profession because it has its established theoretical background, history, and methodology (Morris, 2009). Archival management is a branch of library and information science. Archival science, a subset of library and information science, focuses on selecting, preserving, and managing records and documents with enduring value. Archivists organise and maintain archives, ensuring access to historical materials while

safeguarding their integrity. It involves appraisal, arrangement, description, and preservation principles to support research, accountability, and cultural heritage.

In *The History Teacher*, Julian Boyd states that "historians and librarians are the most indispensable pillars of civilisation" (cited in Emmick, 1989, p.375). This demonstrates that librarians and historians play reciprocal roles in the service of their disciplines. Historical records are among library repositories. The historical records are valuable documents which are consulted by clientele. Historians keep records of events. They help to reconstruct history and gain valuable insights into history. On the other hand, librarians help the public assess these important historical records that are kept as a part of the library's repository.

Origin and Development of Archaeology as a Discipline

Archaeology is said to originate in the 19th century, with figures like Sir Flinders Petrie and Augustus Pitt-Rivers contributing to its development. It evolved as a systematic approach to uncovering and studying human history through mining and investigating artefacts, structures, and cultural remains.

The main goals of archaeology include the discovery and understanding of human history and prehistory through the systematic study of artefacts, structures, and other physical remains (Frieman, 2023). Archaeologists aim to reconstruct past societies, lifestyles, and cultural practices, shedding light on the development of civilisations and contributing to our knowledge of the human experience across time. Additionally, preservation and interpretation of cultural heritage are essential for archaeological goals.

Archaeologists have achieved significant milestones in uncovering the mysteries of the past. These achievements collectively contribute to a deeper comprehension of human history and cultural development. To begin, archaeology has brought about the discovery of ancient civilisation. Archaeologists have unearthed and studied major ancient civilisations, such as the Egyptians, Mesopotamians, Greeks, Romans, Maya, and others, revealing insights into their cultures, technologies, and societal structures (Anifel, 2014). Archaeology has brought about advancements in dating techniques. The development of precise dating methods, such as

radiocarbon dating, has allowed archaeologists to establish accurate timelines for artefacts and sites crucial for constructing historical narratives (Okoronkwo, Emoh, & Ogbuefi, 2020).

Understanding human evolution is one of the primary achievements of archaeology. Archaeological findings and other scientific disciplines have contributed to our understanding of human evolution, tracing early hominins' development and migration patterns (Tryon et al., 2010). Apart from discovering human evolution, archaeology tries to preserve cultural heritage. Archaeologists play a vital role in preserving and protecting cultural heritage sites, artefacts, and monuments, ensuring they are passed down to future generations. Archaeological research has enriched the field of anthropology by providing insights into human behaviour, social structures, and adaptation over time (Rodning, 2024). Archaeologists have reconstructed past environments by analysing flora, fauna, and geological layers, contributing to our understanding of climate change and its impact on human societies (Adams, Ide, Barnett, & Detges, 2018). Integrating technology, such as 3D scanning and GIS (Geographic Information System), has revolutionised archaeological documentation and analysis, enhancing the accuracy and accessibility of findings (Psarros, Stamatopoulos, & Anagnostopoulos, 2022). Interdisciplinary collaborations between archaeologists and others often enrich experts from various fields, including geology, biology, chemistry, and physics, leading to a more comprehensive understanding of archaeological materials and sites.

Origin and Development of Library and Information Science as a Discipline

The origin and development of Library and Information is well-known in the literature. However, briefly stated, the history of Library and Information Science (LIS) dates to ancient civilisations where collections of clay tablets and scrolls were curated. In the Middle Ages, monastic libraries played a key role. The Renaissance saw the rise of private libraries, and the 19th century marked the development of public libraries. Prominent ancient libraries include the Library of Alexandria in Egypt, the Library of Ashurbanipal in Nineveh, and the Library of Pergamum in Anatolia. These libraries were crucial in shaping their societies' intellectual and cultural landscape. Many scholars contributed to the origin and development of library and information science. For instance, Melvil Dewey's decimal classification system, introduced in the late 19th century, greatly influenced library organisation. The 20th century has brought about technological advancements, such as the rise of electronic databases. Today, LIS encompasses digital information management and evolving technologies in the information age. Uses of the library in ancient times

In ancient times and the present day, libraries have served several essential purposes. Libraries are repositories of manuscripts, scrolls, and tablets, preserving cultural, scientific, and religious knowledge. They played a crucial role in safeguarding information for future generations. Libraries were hubs for learning, attracting scholars and students. They provided access to literature, philosophy, mathematics, and various fields of knowledge, contributing to education and intellectual development (Bouaamri, Otike, & Barat, 2022). S. R. Ranganathan, a prominent scholar who contributed to the evolution of library and information science, was a pioneering figure in LIS. Ranganathan developed the "Five Laws of Library Science" and substantially contributed to library classification systems. Known for creating the Dewey Decimal Classification system, Melvil Dewey played a crucial role in standardising library organisation. Another scholar is Michael Gorman. An influential figure in modern LIS, Gorman has contributed to cataloguing standards and shaped the information profession.

While primarily a scientist and engineer, Vannevar Bush's essay "As We May Think" in 1945 laid the groundwork for hypertext and influenced the development of information retrieval systems. In the same way, Marcia Bates, renowned for her work in information-seeking behaviour and user-centred design, contributed to understanding how people search for and use information. Barbara Tillett's work involved developing cataloguing standards, including her work with the Library of Congress. Also, Donald B. Cleveland contributed to information retrieval and online searching; Cleveland's work has impacted the field of information science.

Role of Archivists in Library Practice

Archivists play a crucial role in library practice by managing and preserving records of enduring value. They organise, describe, and maintain collections of historical documents, manuscripts, and other materials. Archivists ensure the long-term accessibility and usability of these records for researchers, scholars, and the general public.

In a library setting, archivists collaborate with librarians to integrate archival materials into the broader collection. They contribute to cataloguing, establish access policies, and assist users in locating relevant archival resources. Archivists also play a crucial role in digitisation efforts, helping to make historical documents available in digital formats for broader dissemination. Archivists in library practice focus on curating and preserving historical records, enriching the library's offerings with valuable resources for research and education.

Archivists assess materials to determine their value and relevance for long-term retention. They help select and acquire records, manuscripts, and other materials for the library's archives. They help arrange and describe manuscripts and records by organising materials systematically, creating finding aids, and making collections accessible to users. They help to implement strategies to protect and prolong the life of documents, including proper storage conditions and conservation efforts.

They help researchers access and use archival materials, guiding them in navigating collections. They employ technology to digitise and make archival materials available online, increasing accessibility. By playing these roles, archivists contribute to the overall mission of libraries to preserve cultural heritage, support research, and provide valuable resources for future generations.
