## DEPLOYMENT OF TECHNOLOGY FOR LIBRARY SERVICE DELIVERY IN POST-COVID-19 PERIOD BY FEMALE LIBRARIANS IN NIGERIA By

#### Abstract

The study examined information service delivery in the post-COVID-19 pandemic era among female librarians in Nigeria. The study was an online survey designed by the researchers with three (3) research objectives of the study. An online self-constructed questionnaire was designed by the researchers. The population of the study comprises all female librarians in Nigeria with WhatsApp accounts. Data was collected through a Google web form which was distributed to various individuals with WhatsApp accounts. A total of three hundred and twenty (320) female librarians responded from different libraries and institutions in Nigeria. The findings revealed that COVID-19 increased the use of social media tools such as WhatsApp, Facebook, Telegram, Zoom and among others; increased the use of ICT for academic collaboration, disrupted library services, affected social interactions between female librarians and users. The study further revealed that technology deployed for service delivery were smartphones, laptops, Zoom, WhatsApp, Telegram, TeamViewer, Instagram, personal computers and tablets. The study revealed that the use of information technology enables female librarians to organise library materials, disseminate information materials and master basic skills in information technology. Finally, the majority of the female librarians emphasised that barriers such as inadequate funding from federal and the State governments, insufficient ICT facilities, subsidy data, inadequate skills, erratic supply of power and lack of incentives were issues affecting the provision of information service delivery in post-COVID-19 era.

# Introduction

A female librarian is a certified librarian in charge of managing library information resources. Her duties in the library may include the selection, processing, organizing and dissemination of information materials for easy accessibility. Omolola and Oyewumi (2017) avowed that a female librarian who has acquired competency in applying theory and technology in the creation, selection, organization and dissemination of information to users. Accordingly, Ogunbadejo (2019) asserted that female librarians combine their qualifications with their role as women to provide information services that can enhance people's lives. Similarly, Ahiauzu and Echem (2019) asserted that female librarians are part of the human resources that make up the workforce of the academic community and justify the height of their relevance in the role of providing fundamental services, facilities and resources in all formats for teaching and research in the institutions.

However, as society is changing, female librarians are picking up new and challenging roles. Ahiauzu and Echem (2019) asserted that to achieve the digital goal of information packaging and dissemination as part of her core activities, it is imperative for the female librarian to best position herself to be equipped with the right knowledge, skill and competence. Ali and Gatiti (2020) asserted that libraries, as social institutions, are responsible for ensuring public health awareness and the provision of up-to-date information to their users. Similarly, Adomi and Oyovwe(2021) asserted that library and information science professionals are equally looking for reliable information about the pandemic to enable them to disseminate useful information to their users.

The study of Chidi-Kalu et al. (2018) reveals that female librarians in their role should educate their patrons in such a way that they will know when they need information, identify the kind of information that will address their particular problem, find their needed information resources, evaluate the information resources, organize the information and use the information effectively in addressing their problems. This can only be achieved when female librarians can provide reliable information on post-COVID-19. Such roles have made female librarians assume the position of and function as instructors, mediators and even in most cases guidance and

counsellor, especially in this era of post-COVID-19. However, studies have been conducted on library and information professionals' information needs during COVID-19 but none have been conducted on the technology deployed in service delivery in post-COVID-19 pandemic period by female librarians in Nigeria. Hence, this study tends to fill this research gap.

#### **Objectives of the study**

The core objective of the study is to ascertain the Deployment of technology in the post-COVID-19 pandemic period by female librarians in Nigeria. The precise objectives are to:

- find out the COVID-19 pandemic effect on services provided by female librarians in Nigeria
- find out the technology deployed by female librarians for service delivery in post- COVID-19 pandemic in Nigeria
- find out the Challenges faced in library service delivery by female librarians in Nigeria after post -COVID-19.

## Literature review

There are several effects of the COVID-19 pandemic on services provided by female librarians in Nigeria such as the increase in the use of technology in service delivery, more innovation in service delivery, increased the use of technology to render services to distant library patrons, increased the use of social media tools, increased the use of ICT for academic research, disruption of library services, libraries were closed and physical social interactions between the librarians and library users was affected. According to IGI Global (2020), the effect of the COVID-19 pandemic made various groups of people within the educational system adapt quickly to the new

environment, whereby female librarians made frantic efforts to ensure that all library resources and services are available to patrons from a remote location.

Adomi and Oyovwe-Tinuoye (2021) asserted that globally teachers, students, and female librarians are being forced to transition to an online-only environment, as numerous schools, universities and libraries are compelled to close their campuses in response to COVID-19 mandates. Fasae, Adekoya and Adegbilero-Iwari (2020) surveyed academic libraries' responses to the COVID-19 pandemic situation in Nigeria. Their findings revealed that some safety measures put in place by the libraries included total closure of the library, provision of hand sanitizers as well as the use of face mask by library users; social distancing measures also put in place as communication was made through social media as well as the termination of physical attendance to library patrons.

There are several technologies deployed for service delivery in post-COVID-19 by female librarians such as Smartphone, laptops, Zoom, WhatsApp, Telegram, personal computers/tablets, Team viewer and Instagram to users. Anwar and Zhiwar (2019) noted that 45% of the world population are active users of social media such as WhatsApp, Zoom, Telegram, Team viewer and Instagram among others, goes to show the role social media plays in information dissemination worldwide. DeBoni (2020) asserted that Nationwide web surveys and even those that cover several countries can generate results in a few weeks, most especially when the recruitment is performed through social networks such as Facebook, Instagram, Twitter, and WhatsApp.

The study of Sawyerr-George et al. (2018) reveals that for female librarians to achieve a feat in their role of ICT empowerment, they must be trained to be innovative and creative so that they can embrace new trends in librarianship with the \_use of ICT to satisfy their users. In sustaining this however, it is necessary that\_

continuous self-improvement, training and retraining be vigorously pursued by the female librarians to avoid being perceived as information and technologically obsolete in this era, but rather, as role models in the ever-learning society (Ahiauzu & Echem ,2019). This implies having up-to-date knowledge of information materials, being proficient and conversant with the use and application of technology tools within her reach, easy manipulation of IT gadgets such as computers, tablets, and laptops among others the ability to effectively interact with library users and assisting them with online materials to suit their needs.

Ahiauzu and Echem (2019) asserted that female librarians in enhancing the digital services to library users in the ever-changing environment are faced with the following challenges range from the issue of inadequate funding from within and outside the library, inadequate sponsorship on the part of parent institutions and government on professional training that will enable them to acquire the needed and relevant skills or knowledge to strengthen their services, the unwillingness of some female librarians in engaging themselves in personal development programmes, lack of time and inadequate provision of technological facilities and infrastructures amongst others. Similarly, Sawyerr-George et al. (2017) revealed that training female librarians play an important role in effective service delivery in their different libraries and that lack of finance hinders their training and education for effective services.

### **Research Methodology**

The researchers adopted a convenience sampling technique for the study because it would facilitate easy and speedy collection of data as the study was conducted when the Nigeria economy is not too palatable in terms of mobility. The researchers designed an online survey with three (3) research objectives of the study. The population of the study consisted of all female librarians in Nigeria with WhatsApp

accounts.

A self-constructed questionnaire entitled: "Technology used for library service delivery in post-COVID-19 by female librarians in Nigeria (TULSDPCOVID-19FLN)". A total of three hundred and twenty (320) female librarians responded from different libraries and institutions in Nigeria. This represents 60.3% of female librarians with WhatsApp accounts in Nigeria.

## **Results and Discussion**

Table 1 reveals the effect of the COVID-19 Pandemic on female librarians in Nigeria. The findings revealed that a majority of the respondents attested that COVID-19 brought about an increase in the use of technology, more innovation, increased the use of technology for distant patrons, increased the use of social media

tools such as WhatsApp, Facebook and Zoom among others, increased the use of ICT for academic research seminars, disrupted library services and effected social interactions between the librarians and the library users. However, Table 3 reveals that the overall mean(2.9) is higher than the criterion mean(2.5) which also indicated that female librarians were affected by COVID-19 as shown in Table 1.

Table 2, reveals that the majority of the respondents attested that technology deployed for service delivery in post-COVID-19 are smartphones, Zoom, laptops, WhatsApp, Telegram, personal computers/tablets, Team viewer and Instagram. The respondents further concur that information technology enable them to organise library materials, disseminate information materials easier, faster and enables them to master basic skills in disseminating information materials. However, Table 4 reveals

that reveals the overall mean (2.8) is higher than the criterion mean (2.5) which also indicated that female librarians deployed technology for service delivery in post-COVID-19 as shown in Table 2. Nationwide web surveys and even those that cover several countries can generate results in a few weeks, most especially when the recruitment is performed through social networks (e.g., Facebook, Instagram, Twitter, and WhatsApp (DeBoni, 2020).

However, this prohibited those who were not on the WhatsApp platform from participating in the survey. Accordingly, it has been observed by De Boni(2020) speed, large samples, and wide scope inherent in e-surveys do not guarantee external validity (representativeness or generalization of the results), which can only be achieved with probability sampling method or census. Therefore, the limitation of the findings of this study stalks from the incompetence to guarantee the representativeness or generalization of the results.

Table 3, reveals that the majority of the respondents indicated that inadequate assistance from the State and FGN in funding e-service in the library,

insufficient ICT facilities, poor signals, erratic supply of power, inadequate training skills on ICT and lack of incentives for female librarians. However, Table 5 reveals that overall mean (2.7) is higher than the criterion mean(2.5) which also indicated that female librarians has challenges for service delivery in post-COVID-19 as shown in Table 3.

This is in line with Sawyerr-George et al. (2017) who found that training female librarians play an important role for effective service delivery in their different libraries, and that lack of finance hinders their training for effective services. This is in agreement with Ahiauzu and Echem (2019) who attested that those female librarians in enhancing the digital services to library users in the ever-changing environment are faced with the following challenges range from the issue of inadequate funding from within and outside the library, inadequate sponsorship on the part of parent institutions and government in professional training that will enable them to acquire the needed and relevant skills or knowledge to strengthen their services, the unwillingness of some female librarians in engaging themselves in personal development programmes, lack of time and inadequate provision of technological facilities and infrastructures amongst others.

### Conclusion

Based on the findings of this study, it is concluded that female librarians were affected by COVID-19 and as such COVID-19 brought about an increase in the use of technology, more innovation, increased the use of technology for distant patrons, increased the use of social media tools such as WhatsApp, Facebook, Zoom among others, increasing the use of ICT for academic research seminars, disrupted library services and effected social interactions between the librarians and the library users in service delivery. Technology deployed for service delivery in post-COVID-19 are

smartphones, Zoom, laptops, WhatsApp, Telegram, personal computers/tablets, Team viewer and Instagram. This technology enables female librarians to organise library materials, disseminate information materials easier, faster and enables them to master basic skills in the dissemination of information materials. Although, inadequate funds, insufficient ICT training and inadequate ICT facilities/gadgets among others. In addition, information got from this research will be made available to the National Universities Commission, Tetfund and all stakeholders of Tertiary institutions on how to improve library services in tertiary institutions in Nigeria.

### Recommendations

- Library management should constantly sponsor female librarians for conferences, workshops and seminars on the latest Information and Communication Technology (ICT) used in library operations for effective service delivery.
- II. Library management should ensure that the latest ICT facilities and gadgets are acquired in the library for effective service delivery.
- III. Library management should be friendly with the university management in order to be getting access to more fund allocated to the library.
- IV. Library management should also be seeking for grants from local and foreign bodies/ agencies in order to build up the standard of library operations.
