PERCIEVED ACCESSIBILITY AND USAGE OF INFORMATION RESOURCES BY SPECIAL NEEDS STUDENTS FOR SUSTAINABLE DEVELOPMENT IN UNIVERSITIES IN NORTH-CENTRAL NIGERIA By

Abstract

This study investigated perceived accessibility and usage of information resources by special needs students for sustainable development in universities in North-central Nigeria. Descriptive research design was used and the population of the study comprises 162 special needs students of public universities located in North-central geopolitical zone. The total population was used as it is small to manage. Self-structured questionnaire was used for data collection. The study revealed that provision of equal access to building infrastructures, training opportunities, involvement of students in some managerial activities, maintaining statistical data and provision of equal access to information resources are factors for sustainable development in the universities with average weighted means of 3.45. It further indicated that there was a fairly positive perception of accessibility and usage of information resources by special needs students on sustainable development in universities with the average weighted mean of 2.43. The study identified challenges related to negative attitudes of staff, inadequate skills of both staff and special needs students and institutional issues, hence it was so significant with average weighted means of 2.71. The study recommended training of library staff, awareness campaign on the available information resources, Orientation of Special Needs Students, provision of essential resources, sound architectural designs and overhauls of the institutions' infrastructures to be accessible to all students, regardless of their abilities.

Introduction

Libraries are broadly divided into four types: Academic, Special, Public and National Libraries. Academic Libraries exist to support the academic activities of their parent institutions. According to Ashikuzzaman (2016) an academic library is the library which is attached to academic institutions like schools, colleges, and universities. Those libraries attached to the universities are referred to as University Libraries. They are meant to support the academic activities of the university. Provision of access to information resources is one of the fundamental functions of the university libraries. All the avalanche information resources in the university library will mean nothing if access is not granted. Therefore, all the university students regardless of level, status and stature are expected to access and use the required information resources available in the University Library. Onye (2016) define accessibility as the extent to which library user obtains services use or retrieves information from the library either in print or electronically. Therefore, accessibility is a means by which users can identify, locate, retrieve or use library resources and services.

If the information resources are not well organized by the library, access could not be made. Agyeiku (2021) asserts that learning materials might be available, that is the library has acquired them, but inaccessible due to poor catalouging, poor arrangement of resources on shelves, poor labeling of book resources, and in a case of electronic resource, inaccessibility can be caused by electricity outages, low bandwidth and lack of information literacy skills. Therefore, access to information resources involve to remove barriers that might impede users, including the special needs students in gaining access to information resources for sustainable development in universities. However, one of the most challenged sets of library users are the 'special needs' otherwise known as persons with

disabilities (PWD). Persons with disabilities are categories of people with defect or abnormality either structural or psychologically to the extent that it is easily noticed and hinders the individual from carrying out daily-activities without the assistance from others.

Statement of the Problem

Sustainable development of any society is not feasible without an inclusive qualitative education system. The education system is not viable without the library which provides relevant information to users including those with special needs. Naturally, the percentage of persons living with impairments is growing as world's population increases. Over 80 million people living in Africa has one form of disability or the other (United Nations Economic Commission for Africa, 2016). Taking into account the ever-increasing number of persons living with disabilities in tertiary institutions like universities, it is crucial that practical measures are taken by universities to cater for their needs by making provisions for them to gain access to inclusive meaningful information for their self-actualization and sustainability. It is against this backdrop the researchers deemed it fit to investigate the accessibility of information resources by special needs students for sustainable development in universities in north-central Nigeria.

Research Questions

- 1. What are the perceived factors of sustainable development for special needs students in universities in North-central Nigeria?
- 2. What is the perceived accessibility and usage of information resources in formats that are accessible and useable by special needs students on sustainable development in universities in North-central Nigeria?

3. What are the challenges of accessibility and usage of information resources in formats that are accessible and useable by special needs students for sustainable development in universities?

Literature Review

Accessibility generally means the practice of making information, activities, or environments sensible, meaningful, and usable for as many people as possible including users with special needs. Nkiko *et al.* (2020) investigated the accessibility of library facilities by wheelchair users in four different kinds of libraries in Lagos State, Nigeria. The researchers found that even though people on wheelchair are supposed to be among the users of library resources and services, the facilities and resources in Nigerian libraries for this group are found to be highly unsatisfactory. Similarly, Ayoung *et al.* (2020) investigated Access to library services and facilities by persons with disability: insights from academic libraries in the Upper East Region of Ghana. The target populations for the study were persons with diverse forms of disability, head librarians, special librarians and library staff. The researchers found that though, most library staff opined that they were aware of disability issues, they indicated that they had no knowledge of some of the services librarians could offer, alternative formats and assistive technologies for PWDs.

Information Resources are the information bearing items that are both in print and non-print format. According to Akanwa (2016), information resources in the library are categorized into three main headings: Books, Audio visuals or Multisensory materials, and Electronic Information Resources. The print resources are known as book resources or book materials; the non-print resources are known as audio visuals; while electronic information resources are information resources that are stored electronically and can be

accessed and retrieved through electronic systems and networks (Akanwa & Udo-Anyanwu, 2017). These information resources are made available in the library for use by all categories of users including those with special needs.

In the same direction, Anaobi and Lawal (2021) asserts that librarians within university libraries have the responsibility of providing exceptional services by performing a variety of tasks such as information analysis and interpretation, packaging and dissemination of information among other things. Access to information resources for all can be made possible through use of assistive tools and technologies. The commonly used technological devices include braille books, talking books, playback machines, audiotapes and screen readers (Okonoko and Ufuoma, 2023). The term "assistive technology" according to Ezeala (2023) has usually been applied to computer hardware and software and electronic devices. Thus, constitutes chunk of information resources by the library. The Assistive Technology Industry Association classifies assistive technologies as any item or piece of hardware, software, or product system that can increase, maintain, or improve the functional capabilities of persons with disabilities (Idiodi and Urhiewhu, 2023).

The concept 'special needs person' is a generic term connoting people with disabilities. These group of persons include the visually, hearing, speech, physical and health impaired, intellectually impaired, learning disabled, and emotional/ behavioural disordered (Omiegbe and Ezehi, 2023). Thus, the term 'special needs' could be used interchangeably with persons with disabilities (PWD), physically challenged or handicapped. As such, the term 'special needs students could mean the umbrella term for students with physically or mentally challenged by medical, spiritual and social effects. Ibrahim (2019) defined 'special needs' as those who deviate from the ordinary person such that they require special attention, to areas that could make life more meaningful and worth living. Uzor

and Ugah (2023) asserts that special needs person includes all persons who, for whatever reasons, are failing to benefit from their right. Sequel to the above definitions, special needs students are students who have the ability and the intelligence to effectively performed but because of impairment, are denied the required services to perform well. The impairment that befalls them may require assistant in form of device or fellow human being, making their needs special as the name suggests, special needs students.

University Libraries are one of the types of Academic Libraries. Academic libraries are those libraries established to serve universities, polytechnics, colleges, schools and all other institutions forming part of, or associated with educational institution (Nwachukwu, 2017). Those academic libraries that are attached to serve universities are refers to as University Libraries. Ashikuzzaman (2023) define university library as a specialized facility within a university or college that serves the academic and research needs of its students, faculty, and staff. Consequentially, university libraries are responsible for provision, organization, preservation and dissemination of information to university students without discrimination.

Sustainable Development is the state of development that is lasting, stable and continuous towards improving the life of man on the planet, earth. Nkata (2020) asserts that sustainable development is the capacity to improve the quality of human life while living within carrying capacity of supporting the ecosystem with the aim to improve the quality of human life and enable people to realize their potentials, and live lives of dignity and fulfillment. Sustainable development in universities therefore is the improvement on equal access to learning, research activities and social interaction amongst students regardless of their abilities.

Methodology

Descriptive research design was adopted for the study. The population comprises 178 special needs students, the mobility and visually impaired in 13 public universities in North-central Nigeria. Complete enumeration was used because of the manageable size of population. The instrument for data collection was structured questionnaire. The researchers used descriptive statistics of frequency counts, percentages and mean to provide answer to research questions applying the Statistical Package of Social Science (SPSS) version 24.

Results and Discussion

Research question 1: What are the perceived factors of sustainable development for special needs students in universities? Table 1:

Table 1 revealed that provision of equal access to building infrastructures; training opportunities; involvement of students in some managerial activities; continuous orientation; maintaining statistical data and provision of equal access to information resources are factors for sustainable development of special needs students in universities in North-central Nigeria with average weighted mean of 3.45. The findings agree with that of Potnis and Mallary (2021) who reported that the studied academic libraries belong to campus-wide systems where information technology services, disability support services, and university administrators, among other units collaborate to provide information services to disabled patrons. The findings also tally with that of Ndiweni *et al.* (2022) who found that great effort has been made to provide inclusive library services to students with disabilities.

Research Question 2: What is the perceived accessibility and usage of information resources in formats that are accessible and useable by special needs students on sustainable development in universities in North-central Nigeria?

Average Weighted Mean 2.43

Table 2 shows the average weighted mean of 2.43 which indicated fairly positive accessibility. The findings were in conformity with that of Eligi and Mwantimwa (2017) whose study on ICT accessibility and usability to support learning of visually-impaired students found that ICTs support innovative learning, encourage independent learning, and promote participatory and collaborative learning. The findings also corroborates with that of Singh (2022) who revealed that most of the law faculties in the universities' investigated have well equipped facilities with assistive technologies accessible for persons with disability.

Research Question 3: What are the challenges to accessibility and usage of information resources in formats that are accessible and useable by special needs students for sustainable development in universities? Table 3 revealed enormous challenges affecting accessibility and usage of information resources by special needs students for sustainable development in universities with the average weighted mean of 2.78. The findings confirm with that of Ekom-Idorenyin (2023) that misconceptions result in negative attitudes which further heightens the propensity for stereotyping of people with disabilities, resulting in stigmatization, discrimination and deprivation. The observed findings underscore the multifaceted nature of challenges facing the accessibility and usage of information resources. The overall consensus suggests that these barriers significantly hinder the accessibility and usability of information resources for special needs students, impacting their educational development and sustainability in universities.

Recommendations

- Universities should prioritize capacity building for staff. The training programmes should
 aim to address operational issues, dispel myths and misconceptions surrounding disabilities,
 and foster a culture of inclusivity and acceptance within the university community
- 2. Universities should design and implement inclusive awareness campaigns. for available resources as well as their knowhow.
- 3. University libraries should inculcate the policy of regular orientation programmes for special needs students on how to operate the available assistive technology devices
- 4. Universities should devise and execute a comprehensive action plan, targeting the provision of essential resources tailored to meet the diverse needs of students with mobility and visual impairments.

5. Efforts should be made by universities to address infrastructural issue like architectural designs and reconstruction of university library buildings to conform with acceptable standard for easy access by special needs students.

Conclusion

This study without doubt has led to the establishment of facts as regards the accessibility of information resources by special needs students on sustainable development in universities. It highlights indicis for sustainable development as equal access to university resources, staff training and inclusivity; fairly positive perception of accessibility and challenges such as negative attitudes of staff, institutional issues, inadequate knowledge and skills for both staff and special needs students. This resonates with previous research that has highlighted similar challenges globally, emphasizing the urgent need for comprehensive reforms in both policy and practice to ensure equitable access to library resources for all students, regardless of their abilities.
